#### b) Neighborhood Traffic Advisory Committee - Nelson Geddes [absent]

- 1. It was mentioned the stop signs at the intersection of Massey & Churchill were not being obeyed. Vehicles slow down somewhat and continue right through. Some suggestions:
  - a. Need to have the stop lines re-painted when do these get refreshed?
  - b. Could we ask for a traffic circle at this intersection to slow down the traffic?

There are no driveways off of Chilliwack so she had to go all the way back up. Can we have a letter sent to the City asking for disability corners on the sidewalks in our area?"

Anyone who has an issue with accessibility can contact the City Engineering department directly with the exact location and they will add this to their current list. They work on these issues as requested.
